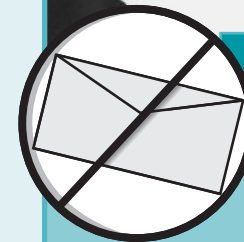

### What Is Click-N-Pay?

Click-n-Pay is a service that makes it simple and convenient to pay your monthly bills. All you have to do is verify that the amount you have been billed is correct, and then schedule the payment via your personal computer and we'll do the rest!

### Why Pay Bills On-Line?

Convenience, convenience and convenience. Your Credit Union's Click-n-Pay features allow you to schedule recurring payments, pay anyone anytime, stop sampling the taste of the glue on those payment envelopes, cut down on trips to the post office and more! Did we mention it's convenient?

### When Can I Start?

Processing your Enrollment Form will take 5 to 7 business days. At that time, you can begin using Click-n-Pay to make your payments!

### How Do I Schedule A Bill For Payment?

Bills are scheduled for payment on-line at [www.newdimensionsfcu.com](http://www.newdimensionsfcu.com). Go to Online Account Access and log in (you must be an Online Anytime user). Choose the Bill Pay option. Click on the Existing Users Login Here link to connect automatically. You simply enter the amount to be paid as well as the bill's due date under the Make a Payment tab. The Click-n-Pay service lets you schedule recurring payments, such as mortgage and car payments, review your bill payment history and maintain a payee database. Adding a new payee is simple, and payments to new payees can begin immediately. All of the Click-n-Pay features help to simplify the process of paying bills.

### How Can I Be Sure Payments Will Be Made On Time?



We request that Click-n-Pay users schedule bills for payment no less than 5 business days prior to the bill's due date. The payment will be sent immediately to ensure it's received on time. Payments may be scheduled as much as one year in advance of their payment date.

### What Account Are The Funds Taken From?

Funds are deducted from your New Dimensions FCU checking account.

### What Does Click-N-Pay Cost?

We do not charge a monthly fee for active users of this service. You will not be charged any Click-n-Pay fees unless the following conditions occur:

- Inactive account for 90 days
- Suspended account
- Past due loan
- Bankruptcy
- Charge off
- Unpaid return check
- Fraud
- Fresh Start program.

Fees you may be assessed are:

- \$15.00 stop payment
- \$5.00 return check item
- \$5.00 monthly inactivity fee (after 90 days)

If you are charged a Click-n-Pay fee, it will be automatically deducted from your checking account and will appear on your monthly statement.
